Hands-on Labs VMware Explore Odyssey Challenge

HOW TO ENTER

To enter the Challenge, Participant needs to be registered for VMware Explore 2022 and create an Odyssey user account as prompted when first logging into the Odyssey environment. The Challenge will take place at VMware Explore from August 29, 2022 8:00 AM PST until September 1, 2022 1:00 PM PST. Participants will have one chance daily to play the Odyssey round game being offered on each of the first three days of VMware Explore. The top 10 players based on score will be invited to participate in a live competition taking place on September 1, 2022, 11:15 AM PST. During the live competition, two games will be played live amongst the 10 highest daily round scorers, with the three highest cumulative scores during the live competition getting prizes.

ELIGIBILITY

By registering to participate in the Challenge, Participant agrees to be bound by these rules and to all decisions of VMware, which are final, binding and conclusive in all matters. Participant is solely responsible for reviewing and understanding his/her employer's policies regarding eligibility to participate in trade promotions such as the Challenge. If Participant takes part in this Challenge in violation of his/her employer policies, Participant may be disqualified from continued involvement in the Challenge or from receiving a prize. JUDGING CRITERIA

The participants will receive a score for each daily round game they play based on accuracy and speed. Participant does not need to participate in all three daily round games if they choose not to. The daily round games will be available to play at the Odyssey area on September 1, 2022, up until one hour before tournament time but these scores will not qualify for the tournament. The top 10 players will be determined by the rankings appearing on the cumulative daily round games leaderboard at 5:00 PM PST on August 31, 2022. The top 10 will be invited to return on September 1, 2022, for the live competition starting at 11:15 AM PST. Two games will be played live amongst the 10 highest daily round scorers with the highest cumulative scores during the live competition getting prizes. In cases of dispute, the VMware Hands-on Labs team reserves the right to pick the winners.

PRIZES

First prize winner – the Participant ranking in first place in the live competition will be awarded one (1) 16-inch MacBook Pro – Space Gray – 32GB Memory, 1TB Storage, with the approximate value of \$3,900.00. No cash alternative or refund will be awarded in lieu of stated prize(s).

Second prize winner – the Participant ranking in second place in the live competition will be awarded one (1) LG Electronics Ultra Short Throw 4K UHD Laser Smart Home Theater CineBeam Projector, with the approximate value of \$3,000.00.

Third prize winner – the Participant ranking in third place in the live competition will be awarded one (1)Apple iPad Pro – 5th generation – 12.9in – 256GB – Space Gray, with the approximate value of \$1,400.00.

The three prize winners will be given their prizes at the conclusion of the Challenge on Thursday, September 1, 2022 1:00PM PST. Each Participant is eligible for giveaways including stickers, T-shirts, and keyrings with a commemorative engraved purple token. The final 10 Participants will be given a special silver 'Finalist' token for their keyring and an Odyssey jacket. The winner will receive a large, gold 'Champion' token for their keyring. The winner may be required to verify his or her entry. Prizes are non-transferable without VMware's prior consent (which may be withheld in its absolute discretion), and may not be resold. If the winner does not claim the prize within the thirty (30) day period, VMware shall have the discretion to award the prize to the runner-up.
